

## Brits Crisis

Briefing

Exco. of Brits Action Comm was ousted after allegations of corruption. Two factions developed. The conflict is unique in that it does not seem to involve vigilantes. Pretoria Comm AGS and the AC. convened a meeting of the two factions last year. It was harmonious. The decision of this meeting was to be communicated to the people by means of a mass meeting.

The mass meeting was conflictual.

After this P.C.C. was drawn in. They convened a mass meeting - this resulted in no progress.

One person was killed after this. Leonard Brown & his faction were arrested & charged for murder. The other faction launched counter attacks.

Brown was driven out of Brits. Strainishes continue.

Brown recruited people from Mandadi.

3 Mandadi Col's were arrested. still in jail. Brown asked for legal assistance from Congress for Human Rights.

In late Nov. Brits Co-ord Comm formed - this included Indian Area. The Brits co-ord Comm has organised a CS in protest against refusal by magistrate to grant permission for a March.

Brown:

I feel I don't have a mandate as others one in Pretoria. In any case I don't know what the problem is all about. An important 3rd party, <sup>(the police)</sup> is not here. Can the other group give an assurance that they would be able to abide by the decisions of this meeting.

Brown faction) Problem is one of fighting. We don't know what the cause is. We knew that after the death of Mankho (Bose), looting & fighting took place. Thereafter Brown & others were released detained. Then a forum was set up where people came together to

discuss the problem. Allegations were made at form. Some were saying Brown & his group murdered the comrade. It was decided that the community should not seek lawyers to bail the arrested cd's. Families would have to attend to this.

Members of the "other" group were released - nobody knew how this happened. Brown & others were released on bail. Upheavals cont'd. Added confusion was when the reprieve was granted. As a result of the uphovels it was decided that no meetings will be held in the community. "Life will stand still".

Subsequent to court victory, Brown suggested that a party be held where 4 beats will be slaughtered. The community was asked to contribute money. \$10 from all employed. A rumour was started by other faction that the party was not going to take place. Some of us suggested that the party be cancelled as it may lead to violence. But the violence cont'd anyway.

In the past for the violence cont'd. On night I heard gunfire at Mike Shogren's house. We learnt that Shogren's wife was shot. Later Mike Shogren & Klansie were also shot & injured. We were surprised that the attackers were not arrested.

In time we were ~~were~~<sup>also</sup> chased out of our homes. I was called W.M.

This year, once again the feud has flared up.

These days it is difficult to attend meetings :: as the poor people attended meetings armed.

Learn Brown told me I am being misused by the BAC.

At a Mass meeting Brown was asked to produce evidence that the BAC misused funds. He refused to do so.

The fight started one day when we were drinking in a Shebeen. Baw & others attacked us with knives etc. Mooshi, Marshal Basie & others were attacked.

A meeting was called by Tate Monabe to make peace & we agreed that we would not fight.
