MESSAGE TO THE CHURCHES

The Rev. John F. Thorne was taken into detention on Saturday, May 24th, 1980 at 12.30 p.m.

Within an hour of Mr. Thorne's arrest, the Secretary of the United Congregational Church of Southern Africa and Dr. Kleinbooi went to John Vorster Square to obtain further information regarding his detention. The officer in charge of the enquiry office refused to discusse the name, telephone number or whereabouts of any senior officer of the Security Branch. He took the names and telephone numbers of the Rev. Joseph wing and Dr. Kleinbook and agreed to communicate them to the head of the Security Branch on the Witwatersraud. He also received Mr. Thorne's medication and promised to make arrangements for him to receive it. No communication was received from the head of Security

Mr. Wing then communicated with the headquarters of the Security Branch in Pretoria. He spoke to a junior officer, who was not aware of Mr. Thorne's detention. The officer agreed to convey Mr. Wing's message and telephone number to the head of Security. There was no response

Mr. Wing also made an unsuccessful attempt to reach the residence fo the Minister of Justice in Cape Town.

At a meeting of ministers in Coronationville that evening, it was agreed that a service of intercession for the Rev. John Thorne should be held at the Congregational Centre, Braamfontein on Monday, May 26th, 1980 at 9.00 a.m., following which the ministers present would walk to John Vorster Square in clerical robes to present a petition expressing solidarity with Mr. Thorne, as a brother minister, and calling for his release

Church leaders and ministers of C.U.C. - related Churches in Johannesburg were contacted by telephone and asked to attend the service and walk thereafter to John Vorster Square to esent the petition.

The service was held as planned on Monday, May 26th, with about people attending. Fifty-three ministers and lay people pined the walk to John Vorster Square. At the corner of ritchard and Sauer Streets they were arrested. They were hen taken to John Vorster Square, where the head of the Security was given the petition for the release of Mr. Thorne, together with a copy of the order of service used at Braamfontein and a brief statement outling the motivation of the protest.

The Rev. John F. Thorne was released at 4 30 p.m. on Monday, May 26th, 1980.

The group of clergy and others were taken into custody and appeared in court on Tuesday, May 27th, 1980. The case was remanded until July 1st, 1980, and they were released on their own recognizances.

A copy of the potition presented to the head of the Security Branch on the Witwatersrand is attached hereto.

The purpose of the walk and petition was not to seek confrontation with the Government, but

- (a) to express solidarity with a brother minister who had identified himself fully with the needs of the community and his people in the exercise of his past ral duties.
- (b) to protest against detention without char es being preferred, and the suspension of the rule of law on which such detention is based.

The Church leaders, ministers and others who were held in custody were deeply aware of the presence of the Folv Spirit with them and of the loving concern and support of the People of God. Their worship and fellowship in the cells was an enriching experience in which they discovered that they were ONE IN THE SPIRIT AND ONE IN THE LORD. The unity which so often seems to elude us in Plans of Union became a reality as together we sought to be faithful to our common Lord and to one another.

DETENTION

of the

REV. JOHN F. THORNE Minister of Bosmont Congregational Church, Former Chairman of the United Congregational Church of Southern Africa, Ex-President and General Secretary of the South African Council of Churches.

WE, Ministers of the Church of Jesus Christ and religious leaders of other Faiths, do hereby protest against the detention of the Rev. John F. Thorne, without reasons being given or any charges preferred.

We respectfully submit:

- That the Rev. John Thorne in identifying with the legitimate aspirations of the young people committed to his mastoral care has acted in obedience to God and in the service of his people.
- That in all his dealings with the students, the parents and the teachers, the Rev. John Thorne has consistently upheld Christian standards of justice and truth.
- 3. That as a respected leader of the Church and the community the Rev. John Thorne has always advocated change by peaceful means. He is a man of peace and has exercised a restraining and reconciling influence during the recent unrest in the schools.
- 4. That the detention of the Rev. John Thorne could exacerhate the volatile situation which prevails in Black education at the present time.

As Ministers of Religion, we, like our brother John Thorne, are bound by our commission to serve God and the people committed to our pastoral care.

If in the exercise of his ministry the Rev. John Thorne is quilty of any offence which warrants detention, we as his fellow ministers are guilty of the same offence: in the exercise of of our ministry our first loyalty must always he to God and the justice of his Kingdom.

We, therefore, hereby express our solidarity with the Rev. John Thorne in the work and witness of the Christian Ministry. We believe that he has based his work and witness on the following Biblical principles, on which we take our stand as the only basis for his action and our total pastoral and social responsibility:-

"Love the Lord your God with all your heart, with all your soul, with all your strength and with all your mind and your neighbour as yourself." St. Luke 10: 27

"What is it that the Lord asks of you? Only to act justly, to love mercy and to walk humbly before God." Micah 6: P

"Is not this what I require of you: to loose the fetters of injustice and to set free those who have been crushed?"

Isaiah 58: 6

"We must obey God rather than men." Act 5: 29

WE HEREBY CALL FOR THE IMMEDIATE RELEASE OF JOHN THORNE FROM OFTENTION
