#### STATEMENT ON A REPUBLIC.

The Black Sash has considered the Republican issue and emphatically rejects the proposals of the Government for a Republic, on the grounds that members of the Government have, through the Senate Act and other laws, proved that they respect neither the spirit underlying the present Constitution, nor the freedom of the individual, nor the rights of minorities.

We believe that any new Constitution, which must command the allegiance of all South Africans, must safeguard the rights of all, and should not be brought into being without the support of the overwhelming majority of all the people in South Africa. Whether this support is indeed a fact cannot be ascertained unless the axact proposals for a new Constitution are made public and time given for consideration thereof.

The Constitution Sub-Committee strongly recommend that the proposed amended wording for Clauses 11,12 and 13 be considered as they do not change the meaning or intention of the constitution, but legally are clearer.

AGREED that the proposed "Travelling Fund" be discussed at the next Conference after Regions have considered the relevant figures.
