WEDNESDAY 3

11 am

Meeting of N.E. (NAT EXEC) at DR MA

It is decided that we send delegate to Addis Ababa. Also that I go down to discuss the matter with A.J. We are served with lavish meal.

- 2/30: I meet (FRANK) Madiba and discuss Swaziland.
- 3/30: I meet G.S. (LION) and discuss the polit situation.
- 6 pm: I meet Pat Molae and he complains that he is being deliberately isolated. Certain youths have been given tasks without reference to youth leadership.

I get the impression that he is bitter and frustrated and not sufficiently militant to take part in any political activity.

THURSDAY 4

Meeting with HJ (HELEN JOSEPH) cancelled.

SUNDAY 7

6 am

I leave for Dbn from J and reach @ 1/30 pm.

@ Ladysmith we come accross Bikel.

We meet N.T.(NAICKER) @ 2/45 and explain our mission.

I meet ~~MANLY~~ at S and explain mission.

Am extremely anxious to see AJ on same day but Dbn's sense of urgency not as sharp as one would expect.

@ 6 pm I meet M.P. (NAICKER)

MONDAY 8

^{GALO}
I see KGALAKI and Ernest. We discuss new students association. The youth in general and polit situation in the Province. They complain bitterly about the lack of enthusiasm and drive on the part of the Senior leadership in the Province and failure of leadership to keep abreast of developments.

At 11 pm I see AJ. He is in high spirits Approve of TRIP, suggests consultation on new Op.

JANUARY 1962

TUESDAY 9

Leave D for J at 7 am and arrive in Joh at 3.45
I send for Gowanini, (DANA NOKWE), Kamela (W. SIS-
WLU), & K (KATHRADE). I have discussion with
Gowanini but K fails to turn up. He was repor-
ted to be boozing. I spent the day at home of
former typist, D (DORCAS).

At 8 I leave for home.

WEDNESDAY 10

I return to home of former typist. I see Madiba
Later I see Zami.

I see Gowanini who reports arrest of Kamela.

Later I meet K who tries to find excuse for the
failure to turn up the previous day on ground
that it had been previously arranged that I sleep
at W'.S. We have a brief tif and later we cool
down and pat each other.

THURSDAY 11

I leave for Lob at 12 and arrive there @ 3/30.
I ascertain that flight had been cancelled from
DAR. I sleep at Fish KEITSING's house. At
midnight I receive report that AM (AMIN KAJEE)
had been arrested for driving whilst under the in-
fluence. I refer to it as an act of amazing ir-
responsibility and a betrayal.

FRIDAY 12

AM pays £5 admission of g. Immigration Officer
calls. I get the shock of my life when I dis-
cover that this same man is head of security
Branch. He informs me that flight had been can-
celled from D and wishes to know my plans. I
politely turn down his suggestion that I stay in
a GOVT House and prefer the simple but warm af-
fection of F.K. and his wife.

I meet Mr Motsete, President of the BPP and Gga-
boesele.

SATURDAY 13

I spend the day reading "Industrial Colour Bar
in S.A." DOXEY and in further discussion with
Mr Motsete, Ggaboesele, Fish and Mlongeni.

We also decide to hide our movements from the
Immigration Officer.

Reports come in that the S.B. from the Union are
around.

JANUARY 1962SUNDAY 14

Accompanied by Mlongeni.

I do some mountain climbing. We start at 8 am and return at 7 pm. It is exerting, exciting and interesting.

MONDAY 15

I continue reading and discussing.

TUESDAY 16

I continue as on previous day.

WEDNESDAY 17

The Immigration Officer sees me again and appeals to me that on NO account must I move around as I might be kidnapped by the SAP.

I gain the impression that whilst there may be genuine concern for my safety, he also wishes to make sure that I should meet people in the B.P.

FRIDAY 19

I fly from GABO (RONES) to MBEYA. We take off at 3 pm and land on banks of Chobe River at 6 pm. On way to Hotel we meet a wild lion. Our host is delayed by rogue elephants.

SATURDAY 20

We take off at 8 and reach MBEYA at 3 pm. We call at TANU Offices and subsequently meet Mr (J. BM) Mwakangale, MP who entertains us. My identity is NOT disclosed.

He is critical of the attitude of TANU on the question of citizenship and reviews the discussion on the citizenship Bill.

SUNDAY 21

At 9 we take off for DAR and land there at 12. I meet (PHILLIP) Matante.

Thereafter I meet FRENE (DJINWALA) and we eventually land at Mr NSILO S'AI, Minister of Commerce.

MONDAY 22

I have discussion with GAMBU (AMBROSE MOKIYANA) Bokwe and Jimmy (JAMES JOBE HADERE) and we all agree that affairs of the ANC must be handled by ANC representatives themselves and NOT by friends however sympathetic they might be. Both Jimmy and GAMBU give details of how embarrassed they (were).

TUESDAY 23

I meet Julius Nyerere and he explains the reasons for his resignation: "to recharge the Party" After 3 hrs discussion we take leave of Julius.

At 6 pm we see the new Premier Rashid Kawawa. The same day a Cabinet reshuffle had been announced and Nsilo had been given Health and Labour.

WEDNESDAY 24

In the morning FRENE and I go to town to purchase a few odds and ends. At 5/45 I meet Vasey ex Minister of Finance. He travels with us as far as Nairobi. Joe (MATHEWS) and I travel to Lagos.

THURSDAY 25

We land at Kano, Nigeria at 10 am. We meet MZwandle Piliso who came on the same plane from Cairo. We reach Lagos 2 hrs thereafter. I meet M. Amechi, Parliamentary Secretary to the Minister of Information who invites me to stay with him. He is a charming direct and popular young man with a very charming wife. I eat fufu for the first time.

FRIDAY 26

Or, (OR TAMBO) RR (ROBERT RESHA) MPJ and I meet McEwan, Secretary General of the NCNC and other officials and we explain our situation. McEwan is keen to know particularly about the policy of cooperation with other population groups in the country. At the end of the discussion, he expresses general satisfaction with our policy.

In the evening we visit Eno Etuk and we play a game of cards which I loose.

SATURDAY 27

We meet Justin Bomboko, Congo Minister of Foreign Affairs. He appears extremely arrogant and not altogether sob. Gives a long lecture on unity and invites us to visit him in Leopoldville. At 3 pm I meet Jaja Wachuku, Nigerian Minister of Foreign Affairs, for about 1 hr. He

SUNDAY 28

At 5 pm we meet President Tubman of Liberia who promises assistance. He explains that he would visit Paris and would return to Monrovia on 12/2/62. 111

Whilst waiting for Tubman we meet Cyrille Adoula. As he could not speak french, we merely shake hands with him.

MONDAY 29

I call for a visa at the Ethiopian Embassy. On our way we pass the Conference Hall and I am told to take cover and look the other way as Colin Legum might recognise me.

In the evening we fly off to Addis Ababa. On the plane I meet Duallo, Secretary - G of the AAPC. I also meet Gaur Radebe, (PETER) Molotse, (VUSUME) Make, Kamanga, Sipalo.

TUESDAY 30

We reach Addis at about 2 pm and we put up at Ras Hotel.

We meet Peter Komange, SG of Pafmeca and have a general discussion with him.

WEDNESDAY 31

We continue our discussion with Luallo.

I also meet Dealo, Ambassador for Guinea in Cairo. Also Tawfik Bouattoura, Algerian Representative in Accra.

Also Abdelaziz from the Cairo Office of Algeria.
