And, I believe, this aspect has been ignored in favour of a more to the <u>defacto</u> segregation of NUSAS, in this debate.

I believe this role of black students within the National Union is an essential one in terms of change within South Africa - and it is sas that this has been ignored in this debate in favour of comments about outdated liberal dogmas and/or concepts of an undefined "Multi-racialism" - Barry Streek.

ELECTION OF EXECUTIVE

Mr Curtis explained the procedure for elections as follows:-

- (I) Nominations would be called for, these must be seconded.
- (2) If a nomination was unopposed, the nominee would be declared elected.
- (3) If there was more than one nomination for the post, the nominees would leave the meeting as well as the visitors. Discussion would then follow. Speeches should be in favour of a nominee rather than against a nominee. The nominees would then return to the meeting and would be entitled to vote.
- (4) Voting would be by secret ballot.
- (5) Only voting members of the Student Assembly would be entitled to vote in elections, and alternate delegates were asked to move to one side to facilitate the distrubtion and collection of ballot papers.
- (6) If there were more than two nominations, the candidate with the most votes would have to receive more votes than the other two candiates combined, that is, an overall majority. If this was not the case, the candidate with the least number of votes would be elimanted and a revote taken.
- (7) Mr Curtis reminded people standing of correlated policy which expressed the hope that students standing for executive positions would be sure that they could serve their full term of office before accepting positions.
