**STATEMENT BY JOSEPH DIRKER:**

I am also the investigation officer in respect of the distribution of the pamphlet – “The ANC says to Vorster and his Gang” that was distributed on **13/8/1970** throughout the entire country in its thousands – one of the methods of distribution was the plastic bucket bomb method – a total of 18 incidents of this method of distribution was brought to the attention of the Police, namely in Johannesburg, Cape Town, Port Elizabeth and Durban. At the same time of the explosions there was also a recording from a cassette player that began to play.

(8) To what extent should we work amongst Africans? The reason for this question is that I know **CORNELIUS** intimately now for the past ten years. He lives in Dobsonville township and works in Rdpt. In the late sixties he was in the local branch of the ANC and (continued) regularly attended our weekly youth congress study-circle meetings. I have had a few discreet talks with him recently and apparently he does

not seem to have attracted much attention from the police. It is in my view that he is politically aware and genuinely desires to play an active role, but at the moment he is at a "loose end" and somewhat bewildered at our past setbacks. I am also casually in contact with young **STEPHEN** who works at the "American Mission Press" in Rdpt. who is conscious of our oppression and hardships.
