## AMC IMSISTS BOYCOTT NOT RACIAL.

IIN a special interview with "New Age," which we reproluce here. Mr. Oliver Tambo. Secretary-General of the ANC. outlines the real aims and nature of the economic boycotl.: The economic boycott is not aimed as Whites, or Afrifaners as such. "New Age" put several questions to Mr. Tambo. Below are the nuestions and his replies.

1. Is a further ist of 1. Is thi boycotl appeal products to be boycolled like. ly to be rcleascid?

Mr. Tambo: We have announced the first list. After full investigation, additions will be made and released at suitable stages of the campaign.
2. Is this a Nitional baycoll?

Mr. Tambo: Yes, it offers an opportunity to the millions of people in all pacts of the country to participate by an act of self-denial, in a nation-wide protest against the arrogance of the Nationalists and their utter contempt for the rights of individuals.
$\therefore$ What mast shopkecpers who presently sell liese soods on the bojreoth lise do?

Mr. Tambo: The boycott commences on June 10. This gives shopkeepers reasonable notice to dispose of and to make no further orders for the affected goods. There is certainly no intention to involve them in losses. On the other hand, we do not believe that they will be acting in their interests it they attempt to oppose, ignore or in any way undermine the carnpaign.

Whilc? arti-Afrikaner? At whom is the bojcoll aimert?

Mr. Tambo: The boycott is not aimed at Whites or Afrikaners as such. The Nationalist l'arty has gone out of its way to set up financial and business ven. tures as a part of its political plan. It is only such enterprises that will be affected by the boycoor. The Congress boycott subcommittee includes European representatives and calls upon anti-Nationalist Afrikaners and other Europeans to join the boycott.

The Congress movement is strongly opposed, on principle, to any form of raciaiism.
6. Critics of the campaign have suggestert that theseare man's other watys of protest open to the people and that a bojcoll of some National. ist goorts is an ineffective mithod of prolest. dny comintert?

Mr. Tambo: There are of course many other ways of protest, and our organisa. sions have been and will continue to be most active in advocating and pursuing such methods. The boycott does. not clash with other kinds of political activity.

In the course of conducting the campaign our organisations will endeavour to persuade the people of the reasons for not buying, the listed products. This is valuable cducational and political wotk.

1 do not think tle economic boycott could be de. seribed as "ineffective." Although one doe; not expect the Govermment to frill overnight as a result. hitting the Nationalists in the sen. sitive region of the pocket may bring them to their senses more effectively than many more conventional protests which they have ignored.

## AFTER THREATEMIME 10 BREAK BOYCOTT SOHOEMAM ADMITS DEFEAT

## Appeal To Reverend Mr. Mahabane

oralHE passing of the Native Lawn Amendmert Act make the calling of the national convention to create a united front ggainst apartheid a matter of the greatest urgency. For this reason, to conitnue to argut about who wili eall it is, in the prevailing circumstances, to pats the buck very dangeroualy:!

There are, of course. very real difficultien on the way, Alr. Mahabane and his Interdenominational African Minisiers' Feleration promiset to call the conference. They have every right to be given the chance to carry out tiseir plans. Of equal importance, also, is the fast that other interested people and organisations are perfectly correct in their seeking nof to place themselves in positions where they could appear as stealing, IDAMF's thunder.

The second reason is also very important. IDAMTT is politically not committed and is therefore in the best position to evo'ke a response among all anti-apartheid groups which would produre the best results postible.

## New Factor

These reasons were vety weighty at the tishe the Bloemfontein conference took its deeision rud ereated rasal problems. Hut diffieution are there to be overcome. fund in doing thlu, one fact reeds to be borne In mind. The treason trials came awistly after the Iloemfontein conference and immobilised some af IDAMP's ablest leaders and friends. This plaeed the Reverend Mr. Mahabane, president of the IDAMF, in the position where he could not move with the speed he trould have desited.

Against this fact and the comditiont created by the Native Lawt Amendment Act, the calling of the national conference must be teen from wholly new perspectives. The times call for bold action inspired by bolder thoug hi and courage.

With this in mind we venture now to make a formal request to both the Interdenominational Africain aliniaters' liederation and the South African Christian Conacti. We request them, in the name of justice and in the name of miltions of Christians who are being ground under by the wicked apartheid doctrine, to cooperate and call the conference jointly.

At one time we thought the incluston of the Dusch Keformed Church among the mpongoring bodies would bea statemanlike thing. After their attitude to the Native Laws Amendment Hill is would either be im. possible for them to aponsor the conference in thind or their inclusion would seriously handicap work in the direction of $a$ united front.

## No isolation

We are not urguing bere that the Dutch Refromed Church thould be isolated. But if they mat to be in that position, nobody can stop them. What the times call for is swift and decisive action, and the only organizations which can give $a$ lead in that direction now are the Christian Council of South Africa. speak. ing very largely for the White Chrissians and the Interdenominatlonal African Ministers' Association, for the Africans.

The conference itself will have to be all-inclusive. No particular, pariy politied line should be tolerated. At Bloemfontein some people from the Lett tried to drag in the freedom Charter into the discussions. Such tactics can very easily disropt the united front we all desire. Emphasis will necessarily bave to be on those thinge where there is maximum unity and these are: (a) the urgert reed to stop apartheid and, (b) agree ment on the ealling of a national convention to turn South Africa along a new rond.

Time is no longer in our favour. Because of this, we would urge both the Christian Council and IDAMF to move with all possible epeed in this matter. In addition, we urge leaders of political and other organjations to give all possible support to the idea of call. ing the conference as soon as possible-possibly within the next three months,
