The 19TH NATIONAL CONFERENCE was opened at a Public Meeting in The St. Thomas' Church Hall, Durban at 8 p.m.

MRS. JEAN SINCLAIR, National President of the Black Sash gave her Annual Address after which Mr. Duchesne Grice addressed the meeting and declared the

SOCIAL PROBLEMS OF OUR SOCIETY : WAGES OR IGNORANCE?

Mrs. K. Gaynor, Chairman of Natal Coastal Region took the Chair.

Mrs. Doreen Patrick/ Page Two/--- - Page Two -

Mrs. Doreen Patrick, who has been instrumental in the organisation and the work of carrying out the Malnutrition Survey, made the introductory speech, giving the background to and the Black Sash involvement in the Survey. The sample taken was the age group one to five years.

The next speaker was Miss. Elizabeth Clarke, B Soc Sc Hon, a social worker from the Charles Johnston Hospital Nqutu. She spoke on the effects of Malnutrition as they see them at Nqutu.

The next speaker was an African Social Worker from Nqutu. She explained the situation occurring among her own people as a result of malnutrition.

Mrs. Fatima Meer, Senior Lecturer in Social Science at the University of Natal, spoke of the effects of poverty and malnutrition on the Indian Community.

Mrs. Mgadi, a Social Educationalist for African Schools, told of the difficulties she encounters among the parents of children in trying to teach them to feed themselves and their children correctly and how to budget to make the best use of the money available for food.

In the afternoon Dr. Anthony Barker, the doctor in charge of the Charles Johnston Hospital gave a most moving account of his work at Nqutu. He spoke too on the Malnutrition Survey. He emphasised the large number of babies admitted to hospital as a result of being looked after by grandmothers, the breakup of family life, as a result of the migrant labour policy and the small sums of money being sent by the wage earners in the cities to keep their families in the homelands. These families depend entirely on these small amounts to feed large households.

After Dr. Barker's address, a panel of Speakers, Dr. Anthony Barker, Dr. Margaret Barker from Nqutu, Mr. Percy Thomas represented Industry and Mrs. Mgadi the Social Educationalist, answered many questions from the audience.

There was a general consensus that poverty was the major cause of malnutrition in the Homelands, but that ignorance aggravated the situation.

Mrs. Patrick and Natal Coastal were warmly congratulated on the organisation of a most interesting Symposium and on their initive and hard work

in carrying out the Malnutrition Survey.

A vote of thanks to all the speakers was proposed by Mrs. Jean Sinclair.

MATTERS ARISING FROM THE MINUTES OF CONFERENCE 1972.

1. Resolution - "That in view of the immediate need for constructive thinking and action in the present grave situation in South Africa, members of the Black Sash through individual and group efforts, should study and make known to others the published reports of the six Commissions of Spro-cas".

Mrs. Johnston reported that four study groups had been set up in Johannesburg and are proving to be very useful. Mrs. Robb said that a group in Cape Town had been studying Dr. Francis Wilson's book on Migrant Labour in South Africa.

2.

"Projects for the year should be set out and the following were suggested : Campaign on African Women, Migrant Labour with due emphasis on Wages, Conditions of employment, Crime, lack of education, poverty etc., involving other organisations if possible".

Regional Reports showed that all Regions had been very active and Fact Papers produced for Conference confirmed this.

RESOLUTION.

"That the Black Sash affiliate to the program for Social Change".

Proposed Mrs. Duncan Seconded Mrs. Streek.

Discussion took place on the word "affiliate" and a vote was taken.

- Housing. Mrs. Barboure, Natal Coastal Region read a lead-in paper. The appalling lack of housing for all black people resulted in Conference calling upon the Prime Minister to halt all group areas removals immediately andto provide the housing urgently need for the homeless as well as people housed under squalid conditions.
- <u>RESOLUTION.</u> "That the Black Sash reiterates its total opposition to any further encroachment on the freedom of the Press, and promises its whole hearted support to the newspapers who have so courageously stood for justice in South Africa and integrity in their profession".

This resolution, proposed by Transvaal Region, was carried unanimously and its contents sent to the press.

RECOMMENDATION. "That the Black Sash be prepared to take immediate action, should it be necessary, on the publication of the reports of the Van Wyk de Vries Commission".

> It was suggested that Regions try to make plans for National action should this be necessary. Regions were asked to try to write articles for their local press on academic freedom.

ITEM FOR DISCUSSION.

A new Black Sash pamphlet emphasising the need for visual impact and readable copy as a means of communicating the aims of the Black Sash and as an encouragement to prospective members.

Mrs. Pearce, Cape Western Region, introduced the discussion and showed Conference a proposed pamphlet depicting four women, one Indian, one Coloured, one African and one White, walking together. The wording read " South Africa's future belongs to you, and you etc., etc.,

This pamphlet will be distributed and followed up with the green pamphlet accepted at Conference last year. Cape Western Region agreed to send copies of the finished pamphlet to each Region and would take orders from Regions requiring them.

THURSDAY 18TH OCTOBER 1973.

A telegram of good wishes was received from Mrs. Rose Franks, Transvaal Region.

FACT PAPER.

Fingo Village to Committee's Drift.

Mrs. Willsworth read this Fact Paper. In duscussion afterwards, it was stated that Committee's Drift was being planned to accommodate 100,000 to 200,000 people and that unemployment in this resettlement village would be likely to become a serious problem. There is practically no industry in Grahamstown.

FACT PAPER.

The Coloured People in Johannesburg.

This paper was drawn up by a group of members of Transvaal Region and was presented by Mrs. Kabak who commented on the important points. She said that there are 90,000 Coloured people in Johannesburg, half of whom were in dire need of decent housing ; education and recreational facilities are totally inadequate. Regions were asked to investigate the facilities for Coloured people in their areas.

RESOLUTION.

"That the Black Sash investigate land tenure and ownership by Black people and the detrimental effect lack of home ownership has on this sector of the population".

It was agreed that further investigations be carried out with regard to the laws and regulations in the Bantustans as well as the effect in both rural and urban areas.

The Resolution was passed unanimously.

FACT PAPER.

A Mine Training Programme for Migrant Workers.

This paper was prepared and introduced by Mrs. Johnston, Transvaal Region. Mrs. Johnston suggested that this programme could be adapted for training workers in any industry.

FACT PAPER.

Federation.

The following resolution was passed unanimously :-

"That the Black Sash study the possibilities of Federation in South Africa and of promoting inter-racial discussions on the subject".

ITEM FOR DISCUSSION.

Tax Structure for Black People.

An introductory paper, written by Mrs. Dyzenhaus, was introduced by Mrs. Anderson, Transvaal Region. The paper revealed that the poorest section of the community was more stringently taxed than any other group.

Mrs. Sinclair suggested that all Regions write an article for the papers on taxation of the African people.

FACT PAPER.

A Survey of Domestic Servants' Wages.

This paper was read by Mrs. Stekhoven of Cape Western Region. A survey of wages and conditions was carried out among the members of the Black Sash in Cape Town. A questionnaire was sent out to 445 members of whom 136 replied.

It was accepted that this was a small sample from a concerned group and was not indicative that wages and conditions would be the same as if the survey had covered a cross section of the public. There was discussion on the figures presented because it was argued that the wages of domestic servants, living in and paid monthly, could not be calculated on an hourly or daily basis. ITEM FOR DISCUSSION.

Overseas Magazine Subscriptions.

After discussion on this item, introduced for Headquarters by Mrs. Johnston, it was agreed that no action would be taken.

NATIONAL CONFERENCE.

Mrs. Robb extended an invitation to hold the next National Conference in Cape Town during <u>March 1975.</u>

The invitation was accepted with pleasure by all delegates and it was agreed that Regions would be consulted about suitable dates.

It was agreed that a Chairman's Conference be held sometime in 1974, at a date to be decided upon. Mrs. Streek asked that this meeting be held in East London and this was gratefully accepted. It was agreed that members of Border Region could be observers at this meeting but that the Chairman reserved the right to hold a closed session if it became necessary.

ELECTION OF HEADQUARTERS REGION.

Border Region had proposed Natal Coastal Region who had accepted nomination.

Mrs. Gaynor, Chairman, Natal Coastal, asked permission to withdraw this acceptance. This was granted.

Transvaal Region was elected unanimously.

Mrs. Robb paid tribute to Transvaal for their work as Headquarters and thanked them for taking on the burden for another year.
