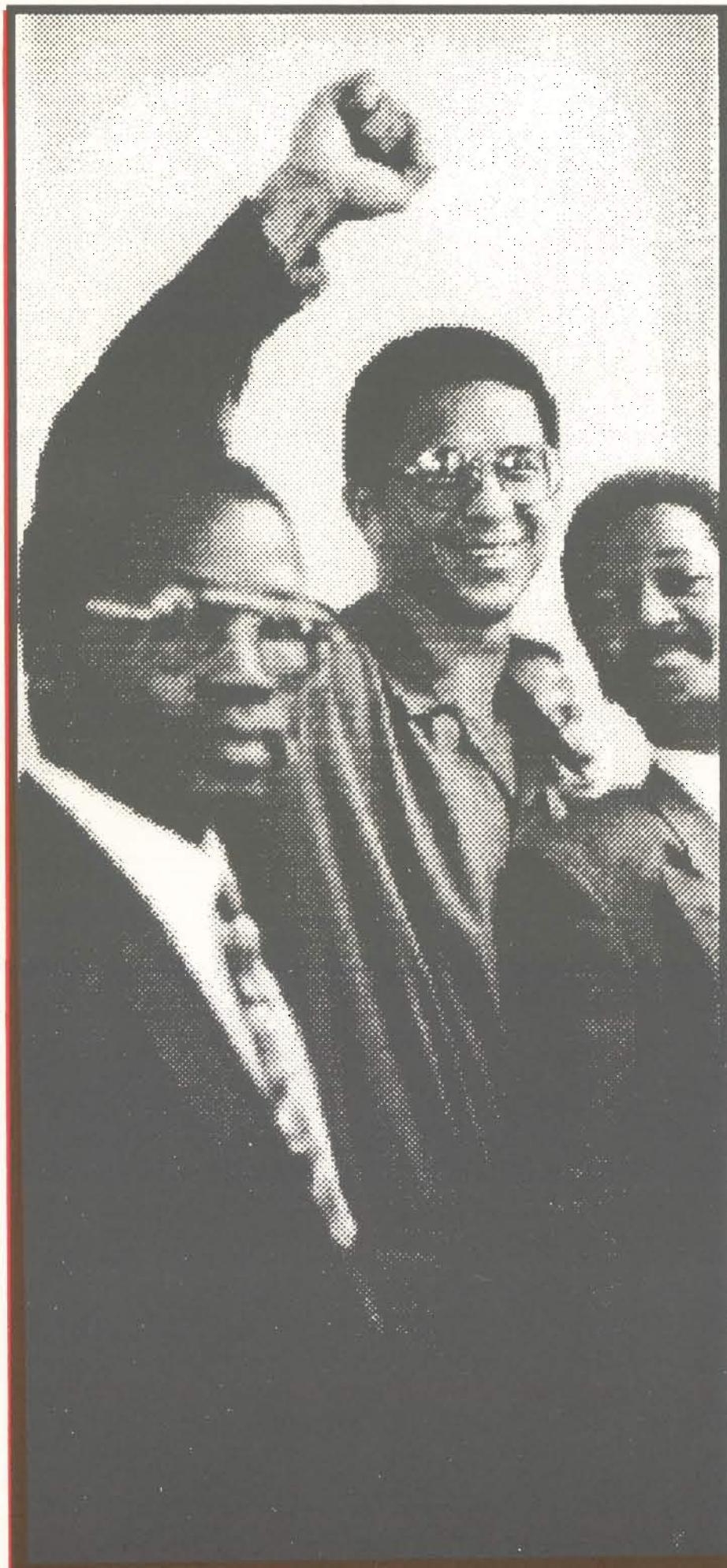


Campaign for Peace and Democracy rolls on

Since June, millions of South Africans have taken action against the undemocratic De Klerk regime. The message is clear: **We want peace and democracy now!**

Over four million people took part in the largest ever stay-away, while over two million actively took part in rallies, marches, occupations of cities and other actions.

But this is not the end. The massacre of unarmed demonstrators in Ciskei is just one example of the determination of De Klerk and his puppets to cling to power. This cannot go unchallenged. The Campaign for Peace and Democracy must continue until all our demands are met.

What are the demands?

Interim Government and Constituent Assembly

We demand a sovereign Constituent Assembly which will be elected on the basis of one-person, one vote in a common voters' roll. Recently, the government provisionally accepted general democratic elements regarding the Constituent Assembly. But they still insist on high percentages and in their attempts to divide South Africa into little independent states. Therefore we must continue to campaign for a truly democratic CA and prevent any attempts by the government to undermine democracy. We must, above all, prepare for elections to ensure that the voice of the ANC carries the day.

Elections for a Constituent Assembly must be supervised by effective bodies which will ensure free political activity throughout the land. The National Party should not be allowed to be both referee and player.

Release all political prisoners now

More than 400 political prisoners remain behind bars, hostages of the National Party. Many other activists have been detained and charged during the mass action campaign. All of them must be released. The regime's attempt to link the release of remaining political prisoners with pardons for the apartheid murderers must be rejected with all the contempt it deserves.

Violence must be brought to an end

Stop state murderers

State covert operations such as the CCB and security police networks must be stopped. The government claims there are no such operations. But the victims of these units in the Vaal Triangle, Addo in the Eastern Cape and other areas know too well that these units continue to operate.

Disarm, disband and confine to barracks all special forces such as Koevoet and 31 and 32 Battalions. The government says that they have been disbanded and integrated into the SADF and SAP. What this means is that they continue operating as small units.

Suspend and charge security force members implicated in the violence. Many such officers remain in the army and police: van der Westhuizen who is chief of SADF Military Intelligence and many more. The recent face-lift of the SAP command structure has not dealt with the real commanders of the hit-squads.

Stop the state-sponsored vigilantes

Ban the carrying of all weapons in public throughout the country. The government has done this only in "unrest areas", where people have already been killed. Even in these areas, the police do not seriously enforce the ban.

Guard, search and fence hostels used as bases for attacks. Upgrade all hostels. The government refuses to do this and calls for more talk and no action.

Free political activity in all parts of the country

The regime says it is not responsible for the repression and murders taking place in Ciskei, KwaZulu, Bophuthatswana, Qwaqwa and other areas. Yet the commanding officers in the bantustans are sent by De Klerk's government. The activities of these tyrants are directed and funded by the regime. The SADF is directly involved in repression in many rural areas.

International monitoring

As a result of our actions, we have forced the government to accept the role of the United Nations, Organisation of African Unity and others in monitoring the violence. It has been forced to accept the report of the UN Secretary General. But the regime will do all it can to undermine and restrict these monitors. It continues to bungle the Boipatong investigation while rejecting the demand for an international commission of inquiry.
